**Junior vendor** (12-16 years old) booth (weekly) fee -- \$10.00 No annual fee for Junior vendors.

**Kid vendor** (11 years and younger) booth (weekly) fee-- \$1.00 No annual fee for Kid vendors.

### Summary of Market Policies:

- Market Policy states that all goods sold at this market must be hand-made or homegrown by the vendor. All vendors must live on the greater Kitsap or Olympic Peninsulas.
- All items must be sold at retail value.
- All craft items are regularly juried; you will be promptly notified of any concerns.
- Vendor set-up starts at 7:00 AM, not before, and all vendors must stay until the end of the Market, usually 2:00. Talk to the Market Manager for emergencies or special cases.
- Vendors are not allowed to have alcohol, drugs, or pets at the Market.
- Smoking by vendors is not allowed on the Market property.
- All vendors who wish to erect canopies on the farmers market site during a normal period of market operations, including the set up and break down period, are required to have their canopies sufficiently and safely anchored to the ground from the time their canopy is put up to the time it is taken down. **Any vendor who fails to properly anchor his or her canopy will not be allowed to sell at the farmers market on that market day, unless that vendor chooses to take down and stow their canopy and sell without it.**

You become a member of the market when you pay your Annual Dues. Craft vendors may be limited in number. You may pay your annual dues with this application or on the first day you sell at the market.
